Naples Free-net Membership and Usage Policy Agreement Updated 6-03-03

As a condition to the user Naples Free-Net computer system I understand and agree to the following:

BASIC WEB PAGE SERVICES:

Free Space: The NFN provides free space to registered non-profit organizations and private individuals who are prepared to create and maintain their own web pages. The NFN Board of Directors establishes the amount of web page space available.

Non-commercial: Commercial/for profit oriented web pages are prohibited on the Naples Free-net except that public recognition may be granted to commercial firms making substantial donations to the NFN, as determined by the NFN Board of Directors.

Policy Conformance: Those creating and maintaining web pages on the NFN must conform to all NFN policies and practices as established from time to time by the NFN Board of Directors.

NFN Rights Reserved: The NFN Board of Directors reserves the exclusive right to block, redact, and remove web pages and their content which in its sole opinion are deemed inappropriate to the NFN.

PREMIUM WEB PAGE SERVICES:

Defined: The NFN offers premium services such as "Storyboard", MS FrontPage Extensions, and Domain name hosting for minimum donations as established by the Naples Free-net Board of Directors.

BASIC MEMBER SERVICES:

Free: The NFN offers free dial in access to the Internet, Email, home page web space (see also "Web page Services") and other services that from time to time are made available by the NFN Board of Directors.

Registration Required: To obtain services individuals and non-profit organizations must truthfully complete the NFN registration process, providing all information required.

Conformance to policies: All members of the Free-Net are expected to read and adhere to the policies that are posted on the Free-Net.

Limits on Service: The NFN reserves the right to limit dial in service to prevent "Hogging" of service by some members to the detriment of others and – in general – to balance the services across the entire membership body.

Expiration of Privileges: Failure to use free membership services for a period set by the NFN Board of Directors shall be cause for termination of privileges in order to make more facilities available to active members.

PREMIUM MEMBER SERVICES:

Minimum Donation Required: The NFN offers premium services to registered members in recognition of minimum annual donation of an amount set by the NFN Board.

Services Available: A premium member shall have all the privileges of a basic member and in addition shall have a "Premium ID" of the member's choosing subject to availability.

Annual Renewal Required: Premium services are awarded for an annual donation. These services shall cease upon failure to renew that annual donation on or before the anniversary date.

PRIVACY OF INFORMATION:

Email: Email content shall be private to NFN members and will not be examined by the Free-Net unless required by law.

Registration Information: Information provided the Free-Net for registration purposes will not be used by the NFN except for legitimate NFN purposes and will not be provided to third parties unless required by law.

Web Page Content: Information posted on web pages by NFN clients or members shall be considered public and not subject to NFN privacy restrictions:

Private Use: All information services and features contained on the Naples Free-Net are intended for the private use of its account holders and any unauthorized use of those materials is expressly forbidden.

CONTRAINTS:

Defined: The successful operation of NFN requires establishment of policies to:

- a) Insure smooth functioning of the system.
- b) Adhere to community standards of decency, and
- c) Establish an ethical and legitimate operating environment.

No Screening: The Naples Free-Net does not screen the information posted on the NFN facility.

Illegal Use Prohibited: The NFN system may not be used for any illegal activity. This also expressly prohibits placement of any text, data, graphics, messages, communications, or other material into the system that is related to any illegal activity.

Commercial Use Prohibited: The Naples Free-Net may not be used to promote or sell a profit-making business's products, or services.

OBSCENITY, INDECENCY, SLANDER, HATE MESSAGES, OR VIOLENCE:

External Information Disclaimer: The Naples Free-Net has no control over material accessible outside the NFN facility.

Obscenity: However, NFN users may not post any item on the NFN facility that would be deemed obscene under Florida Law.

Slander: Slandorous material (publication causing injury to a person's reputation, exposing them to public hatred, contempt, shame, or disgrace) may not be posted on the Naples Free-Net.

Hate: The Naples Free-Net may not be used for hate message or to incite or advocate violence.

Community Standards: Information or graphics deemed by the Naples Free-Net Board of directors to violate acceptable community standards may be removed from the NFN facility.

GENERAL RULES AND AGREEMENT:

1. NFN does not warrant that the functions of the system will meet any specific requirements or that it will operate uninterrupted with error. NFN shall not be liable for damages, whether direct, indirect, incidental or consequential (including lost data, information or lost profits or income) sustained or incurred in connection with the use of the system, the operation of the system, or the inability to use the system.

2. I agree to abide by the rules and regulations regarding system usage that will be promulgated and amended by NFN from time to time. I acknowledge that the policies, rules and regulations of Naples Free-Net will change. I understand that such changes could result in restrictions regarding any aspect of system usage including limitations regarding the persons or organizations who may hold accounts or access the systems, the types of access, the period of permitted usage, the disk space reserved for each accounts' use and other matters. I also understand that abuse of the rules stated by NFN could result in my account being terminated.

3. In consideration for the privilege of using the Naples Free-Net I agree to Indemnify and hold harmless NFN, its officers and directors, operators and agents and any firms or institutions with which they are affiliated for any and all claims of any nature arising out of or in connection with any use or inability to use the Naples Free-Net.
